

**BOROUGH OF INTERLAKEN  
WORKSHOP MINUTES  
APRIL 17, 2013  
7:00 P.M. AT BOROUGH HALL**

The meeting of the Borough of Interlaken was called to order at 7:02 p.m., by Mayor Nohilly. It was followed by a salute to the flag and a moment of silence. The following statement was read by Borough Administrator Reibrich. "The notice of the requirements of the Open Public Meetings Act has been satisfied by forwarding annual notice to the Coaster and Asbury Park Press. A copy of annual notice is posted on the Borough bulletin board and is on file in the Borough Clerk's office."

1. **FIRE/FIRST AID REQUESTS:** The Council began discussion regarding Fire/First Aid Requests from the Allenhurst Fire Department. Councilman Napoli stated that the DCA does surveys for volunteer fire/first aid departments which may aid in gathering information relevant to this decision. Mayor Nohilly stated that surveys or feasibility studies should be initiated by Allenhurst Fire/First Aid. Future cost cutting measures by Allenhurst Fire/First Aid were discussed by council.
2. **PROJECTOR/COMPUTER:** Mayor Nohilly suggested getting a large flat screen television rather than a projector. A large television could be accessed for meetings with a cable and would update current equipment in use. Size, cost and location were discussed. Bill Coy will be asked to get quotes for televisions.
