NOW, THEREFORE, BE IT RESOLVED by the Planning Board of the Borough of Interlaken, that:

The Planning Board hereby engages the services of SANFORD D. BROWN, ESQ. and the firm of Sanford D. Brown, L.L.C. as Board Attorney and PETER R. AVAKIAN, P.E., of Leon S. Avakian, Inc., as Board Engineer and Planner. These appointments are being made under the same terms and conditions as 2016 and for the term of one (1) year, effective January 1, 2017.

1. These appointments are being made without competitive bidding because these appointments involve a member of a recognized profession, licensed and regulated by law, and are, therefore, exempt under N.J.S.A. 40A:11-5.

2. The Planning Board Chairman and Secretary are hereby authorized and directed to execute agreements with SANFORD BROWN, ESQ. and PETER R. AVAKIAN, P.E.

3. A copy of this Resolution shall be published in The Coaster as required by law.

Chairman Papp presented a letter received from applicant, Michael Desarno, 729 Raymere Avenue, stating that the applicant has been charged beyond the collected escrow of \$1,500 and owes approximately \$293.00. The letter from the applicant expresses that the applicant does not feel the amount is owed for additional work that was requested by the Board.

Chairman Papp stated that he feels the additional fees were legitimate. The work was done as part of the Board's required analysis of the application. The Board has a right to ask all questions

Board Attorney Representative Falco stated that the applicant came before the Board without an attorney and just one professional. The information provided by that professional was insufficient. Work was done by the Borough Engineer, Peter Avakian that the applicant's professional should have done to provide the information that the Board required.

The Board had a brief discussion and agreed that the applicant must supplement the escrow account to pay for the additional work.
