D. ADOPTION OF TENTATIVE BUDGET

The Board of Education of Interlaken hereby adopts the following <u>tentative</u> budget for the 2013-2014 school year:

BE IT RESOLVED that the Interlaken Borough Board of Education approve the tentative 2013-2014 School District Budget as follows:

RESOLVED that the Interlaken Board of Education includes in the proposed budget the adjustment for enrollment in the amount of \$159,354. The district intends to utilize this adjustment for tuition costs for the additional students.

RESOLVED that the Interlaken Board of Education includes in the proposed budget the adjustment for banked cap in accordance with N.J.A.C. 6A:23A-10.3(b). The district has fully exhausted all eligible statutory spending authority and must increase the base budget in the amount of \$149,682 for the purpose of funding increased special education costs.

WHEREAS, the Interlaken Board of Education recognizes that Board Members may incur travel expenses related to and within the scope of their current responsibilities and for travel that furthers the efficient operation of the Board of Education; and

WHERAS, N.J.A.C. 6A:23B-1.1 et seq. requires Board members to receive approval of these expenses by a majority of the full voting membership of the Board; now

THEREFORE BE IT RESOLVED, the Board of Education approves travel and related expense reimbursements in accordance with N.J.A.C. 6A:23B-1.2(b), to a maximum expenditure of \$1,000 for all board members.

6.0 OLD BUSINESS

 Mrs. Handerhan reported that we are still awaiting a hearing date on the current litigation matter. Mrs. Handerhan also reported that the preparation of the feasibility study is ongoing.

- Mrs. Weeden requested information on board member training. Mr. Kotch indicated that an email was sent and that he would have the email sent again so that Mrs. Weeden can finish her training obligation before the due date.
- Mrs. Walters requested information on the Personal/Relative Financial Disclosure form that all Board Members are required to complete. Mr. Kotch indicated that an email was sent and that he would have the email sent again so that Mrs. Walters can complete the form before the due date.

8.0 PUBLIC PARTICIPATION

- Keith Miller Bridlemere Avenue Mr. Miller asked Mrs. Handerhan to what study was she referring. Mrs. Handerhan indicated that she was referring to the feasibility study that the State requested us to complete to analyze the feasibility of discontinuing our current send/receive relationship with Asbury Park and establishing a new send/receive with West Long Branch and Shore Regional.
- Mr. Miller informed the Board that the Borough has established Gmail accounts for the Members of the Borough Council and that if the Board was interested, they too could establish Gmail accounts through the Borough as an alternative to using their own personal email accounts for Board of Education matters. Mrs. Handerhan thanked Mr. Miller and indicated that the Board Members would give consideration to this offer, pending approval from the Board's legal counsel.

- Gary Layton Bendermere Avenue Mr. Layton asked for information on what contributed to the increase in the proposed 2013-2014 school budget. Mr. Kotch reported that there was a large increase in special education costs. Approximately 40% of the 2013-2014 school budget can be attributed to special education costs. Typically, approximately 10% of a school budget is attributed to special education costs. Mr. Layton indicated that he understands how quickly special education costs can rise.
- Mr. Layton asked for a brief summary of the current send/receive matter. Mrs. Handerhan provided Mr. Layton with a brief overview.
- Mr. Layton thanked the Board of Education and indicated that he appreciates all the work that the Board does for the residents of Interlaken.
