#### 3. <u>RESOLUTION 2020-39:</u> AUTHORIZING THE COUNTY OF MONMOUTH MOSQUITO CONTROL DIVISION TO CONDUCT AERIAL MOSQUITO CONTROL OPERATIONS WITHIN THE BOROUGH OF INTERLAKEN

#### AUTHORIZING MONMOUTH COUNTY MOSQUITO EXTERMINATION COMMISSION TO APPLY MOSQUITO PESTICIDES

**WHEREAS**, the Monmouth County Board of Chosen Freeholders, pursuant to N.J.S.A. 26:9-27 et seq. has elected through its Mosquito Control Division to perform all acts necessary for the elimination of mosquito breeding areas and/or exterminate mosquitoes within the county; and

**WHEREAS**, the County has instituted an Integrated Pest Management Program consisting of surveillance, water management, biological control, and chemical control to exterminate the mosquito population within the county of Monmouth; and

**WHEREAS**, prior to conducting aerial dispensing operations over a designated "congested area," the County is required, pursuant to Federal Aviation Administration Regulation (FAR Part 137.51), to secure prior written approval from the governing body of the political subdivision over which the aircraft is to be operated; and

**WHEREAS,** the Borough of Interlaken is designated as a "congested area" by the Federal Aviation Administration and the County has requested that this governing body consent to its proposed aerial dispensing operations.

**NOW, THEREFORE, BE IT RESOLVED**, by the Governing Body of the Borough of Interlaken, County of Monmouth, State of New Jersey, hereby authorizes the County of Monmouth Mosquito Control Division or its agent to apply pesticides by aircraft for mosquito control in certain areas of the municipality designated by the County as being either larval mosquito habitat or areas harboring high populations of mosquitoes constituting either a nuisance, a health hazard or both understanding that:

- a. The County shall utilize pesticides, application equipment and aircraft that are approved for aerial applications by the applicable Federal (USEPA) and State (NJDEP) agencies, and
- b. Such operations will be performed in compliance with applicable Federal and State regulations, and
- c. The County will notify the police department of each municipality over which aerial pesticide operations are planned prior to commencement of such operations.

#### 4. <u>**REPORTS/CORRESPONDENCE:**</u>

- Administration/Finance: No report.
- **<u>Public Safety</u>**: Council President White noted that there will be a report for the next meeting.
- <u>Shade Tree Commission</u>: Councilman Fama stated the Commission has prepared a draft for contribution to the Borough newsletter.

Councilman Fama noted that a tree fell in the lake.

Borough Clerk/Administrator Reibrich stated that the tree was on the property of a resident who has been notified.

- <u>Streets & Roads</u>: Borough Clerk/Administrator Reibrich noted that there is a bid opening on March 5, 2020 at 10am for the Woodmere Avenue, Scarba and Rona Streets project. At least four bid packets were picked up.
- <u>Planning Board</u>: Councilman Butler stated there was a memorialization at the last meeting. The subcommittee that was assembled to look at Borough ordinances met with Board Engineer/Planner, Peter Avakian. Board Engineer/Planner Avakian put together a proposal for costs pertaining to an ordinance review. The next step the Board will be taking is to evaluate what changes they would like to bring to Council.

Mayor Nohilly noted that it is not Councilman Butler's responsibility, as Council Liaison, to present and defend what the Planning Board wants to do. The Planning Board should articulate their request in writing to Council.

Councilman Butler stated that there will be an overview of what the Planning Board is looking to do.

Mayor Nohilly noted that there is no point in paying professionals to do what the Planning Board wants, if Council is not in sync with what the Board wants. Changes made to the ordinance is Council's decision, not Planning Board's decision.

- **Board of Education:** No report.
- <u>**Recreation Advisory Committee**</u>: Councilman Watson stated that he will be in contact with the Recreation Committee regarding their contribution to the Borough newsletter.
- **Borough Administrator:** Borough Clerk/Administrator Reibrich noted that bids for the road project are being received March 5, 2020.

Borough Clerk/Administrator Reibrich stated that Primary petitions are due March 30<sup>th</sup> for anyone interested in running.

Borough Clerk/Administrator Reibrich stated that the Allenhurst's Borough Clerk/Administrator has contacted her to request that Interlaken host the Egg Hunt this year. Allenhurst would like to alternate hosting the yearly event.

Council had a brief discussion regarding hosting the Egg Hunt. Location, lack of volunteers, notice to residents and participation of Interlaken residents were discussed.

Councilman Watson will contact the Recreation Committee to discuss hosting the event. Councilman Watson did note that the Committee is currently at a standstill due to the lack of a Chairperson.
