## 3. <u>ORDINANCE 2017-1:</u> AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK PURSUANT TO NJSA 40A:4-45.14

# CALENDAR YEAR 2017 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

**WHEREAS**, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 0.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

**WHEREAS,** N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

**WHEREAS**, the Borough Council of the Borough of Interlaken in the County of Monmouth finds it advisable and necessary to increase its CY 2017 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

**WHEREAS**, the Borough Council hereby determines that a 3.5% increase in the budget for said year, amounting to \$30,822.42 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

**WHEREAS,** the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW THEREFORE BE IT ORDAINED**, by the Borough Council of the Borough of Interlaken, in the County of Monmouth, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2016 budget year, the final appropriations of the Borough of Interlaken shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$30,822.42, and that the CY 2017 municipal budget for the Borough of Interlaken be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED,** that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

### 5. RESOLUTION 2017-45: SELF EXAMINATION OF THE 2017 MUNICIPAL BUDGET

### **Self-Examination of 2017 Municipal Budget**

**WHEREAS**, N.J.S.A. 40A4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination, and

**WHEREAS**, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997, and

**WHEREAS**, pursuant to N.J.A.C. 5:30-7.2 thru 7.5 the Borough of Interlaken has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the Borough of Interlaken meets the necessary conditions to participate in the program for the 2016 budget year.

**BE IT RESOLVED**, by the Borough Council of the Borough of Interlaken that in accordance with N.J.A.C. 5:30-7.6a & b and based upon the Chief Financial Officer's certification, the Governing Body has found the budget has met the following requirements:

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
  - a. Payment of interest and debt redemption charges
  - b. Deferred charges and statutory expenditures
  - c. Cash deficit of preceding year
  - d. Reserve for uncollected taxes
  - e. Other reserves and non-disbursement items
  - f. Any inclusions of amounts required for school purposes
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A.40A:4-45.2 and appropriations for exceptions to limits on appropriations found at 40A:4-45.3 et seq. are fully met (Complies with the "CAP" law.)
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
- 4. That pursuant to the Local Budget Law:
  - a. All estimates of revenue are reasonable, accurate, and correctly stated
  - b. Items of appropriation are properly set forth
  - c. In itemization, form, arrangement, and content the budget will permit the exercise of the comptroller function within the municipality
- 5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A.\_ 40A:4-5 shall not prevent such certification.
- 6. That all other applicable statutory requirements have been fulfilled.

#### 9. <u>DISCUSSION:</u> SIGN ORDINANCE

Mayor Nohilly opened the discussion stating that he would like to come to a conclusion on whether or not there is support for any of the sign ordinance changes that Councilman Franks has brought to the table. He would like to end this discussion at this meeting.

Councilman Franks reiterated his stance on changes he would like to be see made to the current sign ordinance. He indicated that he had support at the last meeting to reduce the size of the construction signs.

Mayor Nohilly asked Councilman Franks to discuss the topic in full and then we would have a voice vote as to whether or not there would be changes made to the current ordinance.

Councilman Franks provided information regarding sign ordinances in other towns and what he feels need to be done to maintain the beauty of the town by reducing the signs. He expressed his desire for support in having one uniform sign size.

Councilman Gunn stated that there has been numerous conversations about changing the sign ordinance. He said he felt that those conversations did not support changes to the ordinance since the first time this topic was discussed. He does not support any changes to the ordinance because he does not feel that this is an issue. Council President White concurred.

Councilman Franks believed there was support for, at the very least, changing the construction sign size that is allowed. Councilman Franks asked the Mayor for to allow a voice vote on the topic.

Mayor Nohilly asked the Council members in attendance to voice vote on whether or not they would like to change the sign ordinance with specifics of definitely changing the size allowed of construction signs.

Councilman Butler said that he supported a change to reduce the size of construction signs allowed. Councilman Gunn and Council President White stated they did not see a need to change the ordinance at all because there is not an abuse of this ordinance and there is no issue.

Councilman Watson indicated that he did not have strong feelings one way or the other regarding the sign ordinance. He voted to not make any changes.

With this result, Mayor Nohilly stated that this discussion would come to an end with no changes being made to the current ordinance.
