BE IT ORDAINED by the Borough Council of the Borough of Interlaken, in the

County of Monmouth and State of New Jersey, that:

SECTION ONE. Sub-section 4-1.6 "HOURS" of the Code of the Borough of

Interlaken is amended and supplemented as follows:

§ 4-1.6 HOURS.

Solicitation shall take place within the Borough only between the hours of 9:00 a.m. and 9:00 7:00 p.m. on weekdays and 9:00 a.m. to 5:00 p.m. on Saturday. A permit shall be effective for three months after the date it is issued.

**SECTION TWO**: All other sections and sub-subsections of Chapter IV, "GENERAL LICENSING," will remain unaltered.

**SECTION THREE**. If any section, subsection, paragraph, sentence or other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance.

**SECTION FOUR**. All ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby replaced to the extent of such inconsistencies.

**SECTION FIVE**. This Ordinance shall take effect immediately upon its final passage and publication according to law.

# BOROUGH OF INTERLAKEN ORDINANCE NO. 2022-3

# AN ORDINANCE OF THE BOROUGH OF INTERLAKEN AMENDING AND SUPPLEMENTING CHAPTER XVIII "STREETS AND SIDEWALKS" TO PROVIDE FOR A SECTION 18-3 "SNOW REMOVAL".

BE IT ORDAINED, by the Borough Council of the Borough of Interlaken, in the County of Monmouth, State of New Jersey, as follows:

**SECTION ONE.** Chapter XVIII "Streets and Sidewalks" is amended and supplemented to add a Section 18-3 as follows:

# **18-3 SNOW REMOVAL**

# 18-3.1 Snow and Ice Removal from Sidewalks

The owner, occupant or tenant of any lot abutting or bordering any street in the Borough shall remove snow and/or ice from any sidewalk for public use on the property. Such removal must result in a path of at least two feet in width for the entire length. In the case of ice which is so frozen that it would make removal impracticable, the owner, occupant or tenant shall cause the same to be covered with sand, salt or other suitable abrasive within sixteen (16) daylight hours after the snow shall have fallen, or, of the ice having formed, whichever is the earlier.

#### 18-3.2 Casting of Snow or Ice

When casting snow or ice, no owner, tenant or occupant of any lot shall throw, place or deposit any snow or ice into or upon any street or into or upon any sidewalk for public use. Any snow or ice inadvertently thrown, placed or deposited into or upon any street or sidewalk must be removed by the owner, tenant or occupant within two (2) hours of being so thrown, placed or deposited.

### 18-3.3 Violations and Penalties

Each and every person violating any of the provisions of this section shall, upon conviction thereof, be liable to the penalty stated in Chapter I, Section 1-5. Each violation of the provisions of this section and each day the same is violated, shall be deemed and taken to be a separate and distinct violation.

**SECTION TWO**. All other sections and subsections of the Borough Code will remain unaltered.

**SECTION THREE**. If any section, subsection, paragraph, sentence or other portion of this Ordinance be adjudged by a Court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance.

**SECTION FOUR**. All ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby replaced to the extent of such inconsistencies.

**SECTION FIVE**. This Ordinance shall take effect immediately upon its final passage and publication according to law.

**WHEREAS**, bids for Bridlemere Park Improvements for the Borough of Interlaken were duly advertised and opened on April 14, 2022; and

**WHEREAS**, the Local Public Contracts Law provides that a municipality may reject all bids when the lowest bid substantially exceeds the funds appropriated for the goods and services provided; and

**WHEREAS**, such additional appropriation would represent a substantial increase in appropriation, and, would fall squarely upon the resident taxpayers.

**WHEREAS**, it has been recommended by the Borough Engineer, Borough Attorney and Borough Council that all bids received be rejected, and the Bridlemere Park Improvements be rebid as soon as is practicable; and

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Interlaken that it has been determined that said bid for the Bridlemere Park Improvements should be rejected in accordance with Local Public Contracts Law, N.J.S.A. 40A:11-13.2
