

WORKSHOP MINUTES
SEPTEMBER 21, 2022
7:00 P.M. AT BOROUGH HALL

The workshop meeting of the Borough of Interlaken was called to order at 7:07 p.m., by Mayor Nohilly. Sunshine Statement was read by Clerk/Administrator, Lori Reibrich. 1. CENTENNIAL CELEBRATION DISCUSSION
