4. RESOLUTION 2015-90: HALLOWEEN CURFEW

ESTABLISHING HALLOWEEN CURFEW HOURS

WHEREAS, the Borough Council of the Borough of Interlaken is of the opinion that it is necessary for the protection of property and citizens of the Borough of Interlaken that regulations and restrictions be imposed during the Halloween period in order to prevent vandalism and to preserve law and order in the Borough of Interlaken during said period of time;

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Interlaken as follows:

- 1. No person under the age of 18 years shall be permitted in any public place, public street or public property between the hours of 8:00 p.m. and 6:00 a.m. prevailing time, on each and every day during the period from October 29th through November 1st inclusive, unless such person during said hours is accompanied by his or her legal guardian or parent over the age of 18 years.
- 2. During said hours and days, no person shall wear any item for the purpose of covering any portion of his or her face, or partial mask in any public place, public street or public property in the Borough of Interlaken. However, all trick-or-treaters must be in costume.
- 3. That all persons, regardless of age, excepting those who are attending minor children who shall participate in the traditional Halloween activity of trick-or-treating within the Borough of Interlaken on October 31, 2015, shall be in costume and shall curtail all trick-or-treating activities by 8:00 p.m. on this date.
- 4. No resident or non-resident minor shall be entitled to be on the streets, thoroughfares and property in the Borough of Interlaken, other than the property and dwelling wherein said

minor resides or is a bona-fide guest of the owner or lessee thereof unless said minor is in the company of an adult over the age of 18, or traveling to or from a civic, church or school function, or employment.

5. Any person over the age of 18 years, who permits, consents or allows any person under the age of 18 years to violate the provisions of this Resolution or any part thereof, shall likewise be guilty of a violation of this Resolution.

Penalty: Violation of this Resolution shall be a fine not to exceed \$100.00 and

will be determined by the Municipal Court.

Enforcement: This Resolution will be enforced by the Borough of Deal Police

Department.

- ADMINISTRATION/FINANCE No report.

- RECREATION ADVISORY COMMITTEE The Council discussed the turn out of the 5K run and that though it was not as heavily attended as in the past, it was a great day. Councilman Handerhan said that next year the run may need some additional advertising to remind runners to attend. The large races are starting to cause the disappearance of small town races.
- SHADE TREE COMMISSION No report.
- PLANNING BOARD Councilman Gunn explained the Planning Board's requirement to review the Master Plan every 10 years. He discussed the past meeting and the discussion had with Borough Engineer Peter Avakian who attended and will help facilitate the Master Plan Report. Councilman Gunn reviewed the administrative items that the Board is removing or changing as far as verbiage. He explained some other areas the Board is reviewing such as what the Planning Board could do to regulate large lots from building out of character homes. Mayor Nohilly and Councilman Gunn discussed the current ordinances and setback rules.

Councilman Gunn said that the Planning Board is also looking into possibly setting up architectural guidelines to be in use during variances. Mayor Nohilly said that this was discussed in the past and it was determined that this was not something that could be easily regulated due to the fact that the homes in Interlaken are not all of the same design. Architectural design is important in the towns like Ocean Grove where there is one Victorian style home. The architectural design idea was discussed in the past and was decided not to be used.

Councilman Gunn said he would keep the Council up to date on the Master Plan review as it continues with the Planning Board.

Councilman Franks questioned where the role of the Construction Officials fell as far as Committees. It was determined to be under Public Safety. Councilman Franks questioned if the Code Enforcement Official is to travel through town and make observations or if he is supposed to act upon complaints to enforce. Mayor Nohilly said he didn't believe he was supposed to patrol the town looking for violations. Borough Administrator Reibrich stated that he has very limited hours with the Borough and most of it is spent reviewing applications, meeting with residents in office about individual project approvals and acting on complaints brought the office. Borough Attorney Shaklee stated that the job description of the Code Enforcement is in the Code Book. He explained that most towns have it written that the Code Enforcement Officials act on a complaint basis only.
