**1. 2017 REMAINING EVENTS /2018 PRELIMINARY EVENT SCHEDULE**

The Mayor and Council discussed Borough events, setting the Holiday Tree Lighting for Sunday, December 3, 2017 at 5pm and the Volunteer Luncheon for December 15, 2017 at noon.

Councilman Gunn suggested a holiday decoration contest. Council thought it may be something to do in the future, as there would not be much time to get it organized.

Mayor Nohilly stated that Christmas light displays were a tradition back in the 40’s and 50’s. Mayor Nohilly believes the Borough called the displays Christmas Town. It was popular and cars would drive throughout the Borough to view the displays. Residents can be informed of the history. The tradition can be revived.

Council discussed the joint events with Allenhurst. Councilman Butler complimented the Halloween event with Allenhurst. Stating that the Allenhurst Fire Department, DPW and Allenhurst Police were all involved.
