5. <u>RESOLUTION 2014-117:</u> AUTHORIZING A REQUEST FOR PROPOSAL

AUTHORIZING BOROUGH CLERK TO RECEIVE REQUEST FOR PROPOSALS FOR CONSULTING SERVICES FOR FEASIBILITY STUDY

WHEREAS, on November 12th, 2014 the Governing Body of the Borough of Interlaken held an open joint meeting with the Village of Loch Arbour; and

WHEREAS, at the joint meeting Loch Arbour made a presentation regarding a potential municipal consolidation of the Village of Loch Arbour into the Borough of Interlaken; and

WHEREAS, the Borough Council of the Borough of Interlaken desires to perform a municipal consolidation feasibility study to evaluate potential benefits and risks to the Borough of Interlaken;

NOW THEREFORE BE IT RESOLVED that the Borough Administrator/Municipal Clerk is authorized to seek Request for Proposals (RFP) from a qualified consultant that have experience in municipal consolidation to perform said feasibility study;

Councilman Napoli stated that there was a companion resolution and would like for it to be part of the resolution.

Mayor Nohilly stated that Councilman Napoli had originally written a lengthy resolution and the Borough Clerk condensed it.

Councilman Napoli stated that the motion was not to go out for a feasibility study. It is a motion to seek proposals in the event a new Council was to have interest. They would have a successful source of applicants. There is no funding. There is no feasibility study. It is only an effort to seek consultants.

Mayor Nohilly stated that the vote would not be approving a proposal. The vote would be to approve a request for proposals.

Councilman Napoli addressed Councilwoman elect Horowitz's earlier questions stating she had excellent questions. Councilman Napoli stated that it would not be just a feasibility study, but also an analysis of the impact of a merger.

Councilman Napoli MOTIONED to approve the resolution, seconded by Councilman Handerhan.

Mayor Nohilly stated that the matter will go before the new Council and fully anticipates the Borough will get to the study.

Councilman Napoli questioned Borough Attorney Shaklee regarding the Mayor's abstention.

Borough Attorney Shaklee stated that the resolution did not pass.

Mayor Nohilly felt that the Council should not start out with a tie.

Councilman Handerhan agreed. The new Council should vote on it and if they want to end it then that would be fine.

Mayor Nohilly stated that there is potential for both municipalities. More has to be covered regarding the benefits and risks.
