# PUBLIC COMMENTS ON THE BUDGET

 Robert Napoli – Windermere Avenue –Mr. Napoli indicated that he had read in the newspaper that Interlaken was to receive an additional \$100,000 in state aid. Mr. Kotch indicated that that was incorrect and per the state aid notice issued to Interlaken by the NJ Department of Education, Interlaken's state aid allocation for the 2012-2013 school year was \$52,523.

 Mrs. Wong mentioned the letter that was received by the residents from Joe Passiment, Interim Executive County Superintendent. Mrs. Wong indicated that the board and the board attorney are working closely with the County and the State on this matter.

### 9.0 PUBLIC PARTICIPATION

- Bill Dalton Grassmere Avenue Mr. Dalton commented on the two letters from Joe Passiment, one last week and one from August. He asked how many students currently attended the West Long Branch Schools and Shore Regional and how many students in total in the Borough. Mrs. Wong indicated that there were 17 students at the two schools and approximately 50 students in the Borough. Mrs. Wong also indicated that the only goal of the Board of Education was to find the best placement for the students of Interlaken at the least cost to the taxpayers. Mr. Dalton indicated that he agrees that Asbury Park is not a viable educational solution and encouraged the Board to do their homework and not put the town in peril.
- Merv Frank Bendermere Avenue Asked how many children of the board members are attending either West Long Branch or Shore Regional.
- Michelle Turnay Grassmere Avenue Mrs. Turnay informed the Board that she has a
  two and a five year-old and wanted to know how to obtain information on schooling.
  Mrs. Wong indicated that the best course of action was to attend the monthly board of
  education meeting. Mrs. Turnay also asked about the send/receive relationship with
  WLB and Shore. Mrs. Handerhan indicated that we have filed documents with the State
  and have been in a holding pattern awaiting answers.
- Christine Repath Westra Street Can current students still attend WLB and Shore at the parent's expense? Mrs. Handerhan answered yes.
- Marguerite Dalton Grassmere Avenue Asked if regionalization was still an option.
   Mrs. Wong indicated that regionalization is not the direction that the Board and the State are looking.
- Robert Napoli Windermere Avenue Asked if the State knows about the letter from Joe Passiment. Mrs. Wong indicated that we do not know. Mr. Napoli also indicated that he is diametrically opposed to regionalization. He also indicated that Interlaken has already benefited with the ability of the residents of Interlaken to be able to send their children to WLB or Shore Regional, even if at the parent's expense.
- Andrew DePrisco Fernmere Avenue Asked if the Board passed the resolution per the letter from Joe Passiment. Mrs. Wong indicated that the resolution would be discussed as a legal matter in closed executive session.

The Board indicated that they were not in support of this resolution, but would cooperate with Mr. Passiment in filing the proper paperwork and following all other procedures related to this matter. Unable to obtain a motion for the addition of this resolution to the agenda, Mr. Kotch excluded the resolution from the agenda.
